

I Apply in Vain for the Section I Seminar Lead

I had high hopes of being selected for the position. Then I ran it by Sam and John. John gave me a 0% chance of being selected. After I wrote the above, that evening, I was called in as one of four applicants being interviewed. I was very impressed with the professional manner in which it was conducted, with 6-7^{inmate} leaders present. Though there were a couple of rough patches, I thought it went quite well.

Then later, this morning, Brian Davis, who~~s~~ is over supervising, pulled me aside to tell me why they didn't select me. I told him he could be direct, so he was. I could see that my problem was that I wasn't speaking their language. With his pointers, I could see how to be suc-

cessful next go-around. e.g. When they asked (2) about how I use my time, and to give an example, they were looking for a checklist of tools. What I said was to the effect: "My time is so precious to me that I'm able to get 1.5-hrs more by walking at ^{wound} 4:30 am, turning on the news, stop putting my ear buds in, closing my eyes, taking notes on key points (via tablet light^{\$}, to see), dozing off during commercials. My body thinks I'm asleep." That was so far outside the box of what they were used to that they didn't know what to make of it, so I scored low on that one. (Extraordinary measure.)

Feeling under appreciated, I told him, "I guess [not] you're not ready for me yet." He took that as arrogance. I also said I was partially relieved because my plate is already so full. Earlier, I mentioned that the reason they don't relate to me is because I'm so far to the right on the bell curve. I don't fault them for that.

¶ They're doing a great job rolling out this program. I'm super impressed.
