7/6 Theft Unresolved; UDC Complicity; List of Complaints [about Utah State Correctional Facility]

On 7/6, after noon count, I was moved because my celly, Dustin Larsen, made a false (slandorous) claim about me. (His racket?) The officers let him roll up my stuff, despite my protests. I just needed another 5 minutes, supervised, to roll it up myself. This is on you.

He stole 23+ items of mine, worth \$100-200, e.g. MP3 player, radio, booklight, batteries, towel, \$9.00 body wash, shower shoes (black gators), even my diabetic supplies (to prevent crashing): papers, cushions, peanut butter (new jar), toasted O's honey (1/3 large bag), Fogs. He even stole petty stuff: comb, floss loops.

I reported this in detail that night, with receipts of several key items, to Officer Stuart, who relayed it to Sgt. Hatch. I ~~was~~ asked for urgent action so Larsen wouldn't have time to file off the UDC-done etchings of my name on several items (MP3 player, as a tell, shows my name when powering on, with the cord, batteries shot), trade, eat, dispose...

I've been requesting action on this twice each day since, of both the day and the night crews.

Nothing has been done as far as I know.

Are you (UDC) going to let him get away with this? This makes you auxiliary to the crime, as does delay.

I also asked to go to OMR [Offender Management Review — ②
tribunal] about this. But with how they've disregarded all previous OMR
requests since I came to Max (wrongfully) on 3/6, I'm not hopeful
they will see me for this.

How evil are you getting? Worse than many incarcerated here.

I asked C.O. Stuart for copies of my report & receipts which
I need back. He said he would the next night. Didn't.

Is there anyone with integrity working among you who
will help?

I need my staff back.

[Utah Department of Corrections]
You guys (UDC) will cover-up for each other if I grieve this,
asking for refunds. So corrupt.

You wonder why you're short on staff. Who would want to join
such a derelict bunch of lazy losers (attitude, not inherent)?

REMEDIES
Change your culture. Raise your standards. You are a lousy
lot as you are presently.

You need new leadership. Warden Sharon D'Amico is the most
evil officer I ever met.

"All in, synced up" would be a great remedy motto: all in with
your unique mission in life; synced up with diversity in all you do.

Misc. Samples of UDC Evil / Dereliction

- You don't (or just rarely) provide us Max inmates with DX (basic clothing
supply / replacement, towels, pshbags, shoes)
 - o I had a celly (Smithy) go 2⁺ months without a towel (not sanitary
borrowed mine)
 - o Another (Nsch) got no extra underwear or socks for that long.
 - o I was advocating for a week for Larsen to get a towel before he pulled
his theft.

- You put me with a celly I had an active safety on (Fernandez, 3/10 incident / ³ Person threat safety) on 5/21, 22, and didn't get me out of there for 18 hours. He said, "One of us is going to end up in the hospital seriously injured, shanked," in front of 2 officers (Hertz, Falatan). [Gratefully, I was able to tame the tiger.]
- Housing blocked the grievance I wrote^{about this}. It wasn't logged/mailed 5/28. They also blocked a 30-page copy I made for Turning Point USA.
- I requested to press charges on an inmate, Ian, who on 2/11 yelled that he was going to kill me, then 2-3 times a day walked by my cell (TRO cell, no access - then) and pantomimed shooting me with a gun, often multiple times, "bam, bam, bam, bam, bam". Housing took 13 days to get me a safety form and claimed I didn't broach this in OMR on 3/4, when I very much did. UOC hasn't interviewed me about pressing ~~car~~ charges - most likely because UOC's complicity would be highlighted. The Warden's office is covering all this up. "No merit." Cameras would say otherwise. Think Tyler Robinson.
- When I first got here (Max), you put me in 4 serious dangers in 2 weeks (including Ian, which was why my move to Max was finally accelerated 3/6), then said my claims had "no merit". One of them, (3/18 Adrian) ~~do~~ said I should be dead and was making hooch (prison alcohol) to get in the mood to do the job. Finally, when he was pushing & hitting me on 3/18 I was moved - 4 days after I'd ^{al-}ready pushed the button to report the danger.
- Officers readily say they'll do something you need, when they have no intention of actually doing it.
- e.g. We have to ask 5-6 times on average to get forms, red envelopes.
- You act all busy in the section, then go out into the hall and kick back, chit chatting, laughing, not a care.
- You (DPO) block purchase of many writing supplies (erasers, 10x13 envelopes, clear 3-ring binder), despite 1st amendment requirements.
- You absconded with much property in the "Reset" (6/9) over petty and even non-existence reasons. I saw a female officer dragging (couldn't carry) a

a pin bag of an inmate, bouncing it down the stairs as she walked. Another gripped a TV on the screen, stressing it. Total disregard.

- Officers broke my TV when rolling up my stuff 1/26 (TRO [Temporarily Restrained Offender]) and took no responsibility for it. (Property 'Disposition' F 343898 labeled it "broken".) It was working fine when I was taken as TRO.
- Inmates are allowed 4 inches of paper work. I'm a writer and news man, so I got a property contract to allow much more than that. When officers rolled up my stuff on 1/26, they absconded 2 1/2 feet of my valuable writings & reference material, no recourse. Gone from my access, 1st Amendment violation. The contract didn't transfer when I was moved to another building.
- Housing has been losing or absconding with much of my outgoing mail packets. 4 of 9 money transfers for postage have not been processed 5/17-6/14 (I've not done one since). One was delayed 18 days. 1st Amendment violation.
- Twice, my laundry has not come back. I've had to borrow my celly's clothes when washing my own clothes, because WDC is so slow to replenish missing items. (see above) Most just wash their clothes themselves, not send it to laundry, it's so unreliable.
- I've been waiting 3 months for Medical to provide toe nail clippers for my fungal toe nails. The prison doesn't allow nail clippers.
- Writing grievances is a waste of time / joke, unless you have money to pay attorneys on the outside - who require Level 3 grievance exhaustion, after which it is disallowed by ridiculous provisions. WDC seems to have no intention of remedying problems, only of how to wriggle out of responsibility.
- Despite the value of what I'm doing for the salvation of the planet (See IndComing.org - great content hidden by a well-meaning webmaster volunteer's cheesiness.), they treat me like a LIP (least-important person).

Not All Bad - Max Doing Some Things Well

- Culinary (not Max) does a good job. We eat better than 80% of the planet.
- Though the timing is widely varied, the meal delivery has been reliable for at least arriving.
- Ditto Pill Line (which timing is much more reliable) [Room Service 0, we stay out]
- Toilet paper and paper sack delivery has been reliable. [Inmate culture wastes toilet paper like its free, and officers don't care. They'll use 10 feet of TP to dry a bowl they just washed, or a spoon. They also flush the toilet as if water ~~was~~ is unlimited, not weighing the ^{brought in} processing costs; flush all kinds of junk down the toilet - bad habits for when they get out.]
- Dentist visits are quick: to/from and service provided by Dr. Richards, who is very polite, and talented - "Nascar Dentist" [cuts corners?]

Conclusion

They say, "you can tell a lot about a society by how they treat their prisoners." What does all this say about Utah / Mormons?
